



# 2021-2022 COVID GUIDE

## Masks

We encourage and support any Eagle wishing to wear a mask. Consistent with the wishes of Oklahoma voters, as revealed in Senate Bill 658, **masks will not be required unless Oklahoma County is declared to be in a state of emergency.** If our county does enter a state of emergency, we will activate mask protocols for the 5<sup>th</sup>-12<sup>th</sup> grades only and as follows:

5 <sup>th</sup> -12 <sup>th</sup> Grade Cohort	Protocol
0-9 active cases	Masks supported, not required.
10-14 active cases	Masks will be required "when traveling and when close." Masks will be strongly recommended in the classroom, but not required if consistent distance (3ft+) is achieved.
15+ active cases	Masks will be required at all times. Group activities limited.

## Stay Home When Sick

Families should self-check prior to coming to school each day. Students displaying COVID-like symptoms or presenting a fever of 100.4 or higher should stay home.

## Remote Learning

Families should anticipate remaining in-person for the duration of the year. Remote learning will only be activated if government mandated or in an extreme situation in which quarantine counts among staff physically limit our ability to provide in-person learning.

## Vaccination Communication

We encourage families to consider vaccination, but **OCA will not require vaccines, nor will families be asked about their vaccination status.** However, families may wish to volunteer vaccination information in instances of quarantine (see page 2).

## Social Distancing

As possible, we encourage all Eagles to maintain a distance of **3+ feet** from others.

## Cleaning

We will continue to clean and disinfect all rooms daily. Areas known to be impacted by the virus will receive immediate deep cleaning, as well.

## Campus Guests

Guests and volunteers are welcome, but all guests should do a self-check for wellness prior to visiting and should be mindful in limiting the frequency/duration of their trips to campus.

## Water Fountains

Public water fountains will remain off for Fall 2021. A bottle-filling station will be available in the Secondary Building. Elementary teachers will continue to provide water in the classroom.

## Air Filtration

Every classroom is now equipped with a Vollara air filtration system, which uses a self-contained UV and HEPA filter system to eliminate 99.9% of airborne contaminants. *(Students are not exposed to UV as part of this filtration system.)*

# "CLOSE CONTACT" & QUARANTINE

Close Contact = within 3ft, unmasked, for 15+ minutes throughout the day

No Quarantine Required for Eagles Who

- Are fully vaccinated (voluntary proof necessary),
- Have recovered from COVID-19 in the last 3 months, and/or
- Were masked during the instance of possible exposure.

## QUARANTINE TIMING

A **student with confirmed close exposure** can return to campus when:

- It's been 5 days symptom-free since the last moment of exposure
- AND, preferably, student has tested negative on or after day 5.

A **symptomatic positive case** can return to campus after the following criteria are met:

- It's been at least 5 days since the onset of symptoms, AND
- Symptoms are improving, AND
- It's been at least 24 hours since last recording a fever.
- Returning Eagle must wear a mask for five additional days after return. *(Family may opt for a 10-day quarantine instead of returning with a mask, if desired.)*

An **asymptomatic positive case** can return to campus when:

- It's been at least 5 days, symptom-free, since the time of testing.
- Returning Eagle must wear a mask for five additional days after return. *(Family may opt for a 10-day quarantine instead of returning with a mask, if desired.)*

If you **share close living space with a confirmed case**, you may return to campus when:

- Positive case is no longer under quarantine restriction, AND one of the following for you:
  - Negative test result OR
  - Doctor's recommendation to return OR
  - Five (5) days *since last close contact with positive case*.
